RESOLUTION NO. 2018-04 TO AUTHORIZE THE DEPARTMENT OF PUBLIC SAFETY TO APPLY FOR A STATE OF SOUTH CAROLINA, DEPARTMENT OF PUBLIC SAFETY, HIGHWAY SAFETY GRANT

WHEREAS, the City has been made aware of a Grant being offered by the South Carolina Department of Public Safety that would fund the hiring of two (2) dedicated DUI Enforcement Officers by the City; and,

WHEREAS, such Grant will provide the cost and expenses necessary to employ, equip and compensate the two (2) officers for a period of one (1) year; and,

WHEREAS, there is no requirement for any matching funds by the City related to this Grant; and,

WHEREAS, the City has received and reviewed the Grant Application T19030 and determines that applying for this Grant is in the best interest of the City and such Grant should be accepted by the City if awarded.

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of North Augusta, South Carolina, in meeting duly assembled and by the authority thereof, that:

- 1. The City authorizes the Department of Public Safety to submit Highway Safety Grant Application #T19030 for the Grant period of 10/01/2018-9/30/2019, such project titled: DUI Enforcement Team.
- That the Director of Public Safety is specifically authorized to execute any and all documents on behalf of the City in order to apply for and accept such Grant if awarded.
- 3. That the Grant funds, if awarded, shall be utilized in accordance with the requirements of said Grant and specifically for the hiring, training and equipping of two (2) DUI Enforcement Officers.
