The City of North Augusta will receive bids for the **Edgewood Square Stormwater Pond Clearing** project until 1:00 p.m. on ~~Thursday~~ **Friday**, June 21, 2019, at which time all bids will be publicly opened and read.

The project consists of, but is not limited to the following major elements: Clearing a stormwater retention pond to return it to the designed condition. The pond design site plan is on Page 3 & 4 of this solicitation. The stormwater pond is located behind the Edgewood Square Shopping Center on Edgewood Drive and Highway 25 in North Augusta. The pond is approximately 1.6 acres, but the vegetation to be cleared does not cover the entire area. The work will include tree removal with work conditions located in areas that will require specialized equipment to prevent impacting surrounding residential homes and property. Every effort must be taken to reduce soil disturbance within the pond and on the pond dams. All stumps will remain in place but shall be cut very low to the ground to allow for routine vegetation management in the future.

A PREBID Mandatory Site Visit is required: A pre bid walk-down of the project to fully explain the scope of work with **will be held on June 14 at 9:00 a.m.** on site at 101 Edgewood Drive, North Augusta, SC 29841, behind the closed BiLo Store. You must be accompanied by a city representative at this location. Do not come after or before the meeting. You must sign-in that you attended the event. The contractor will furnish all labor, materials, equipment, services, transportation, insurance and daily expenses to meet the requirements of this scope of work and specifications. Sediment & erosion BMPs to prevent offsite impacts will be expected as necessary. Prices shall be inclusive of all costs.

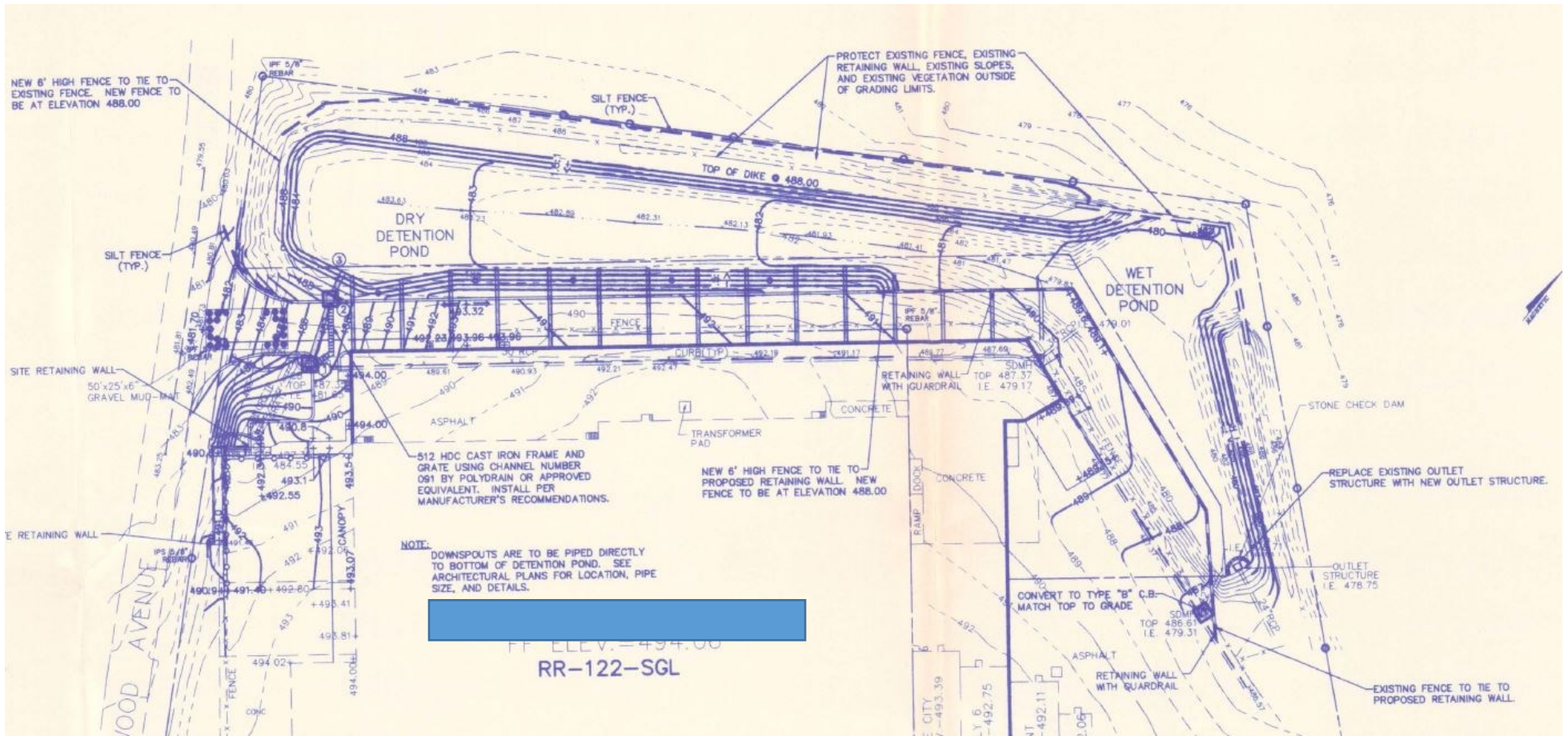

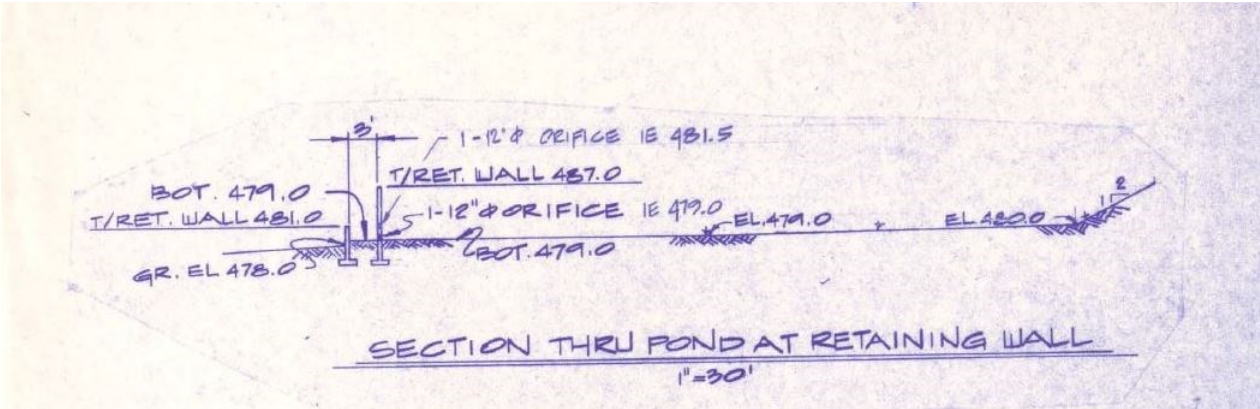
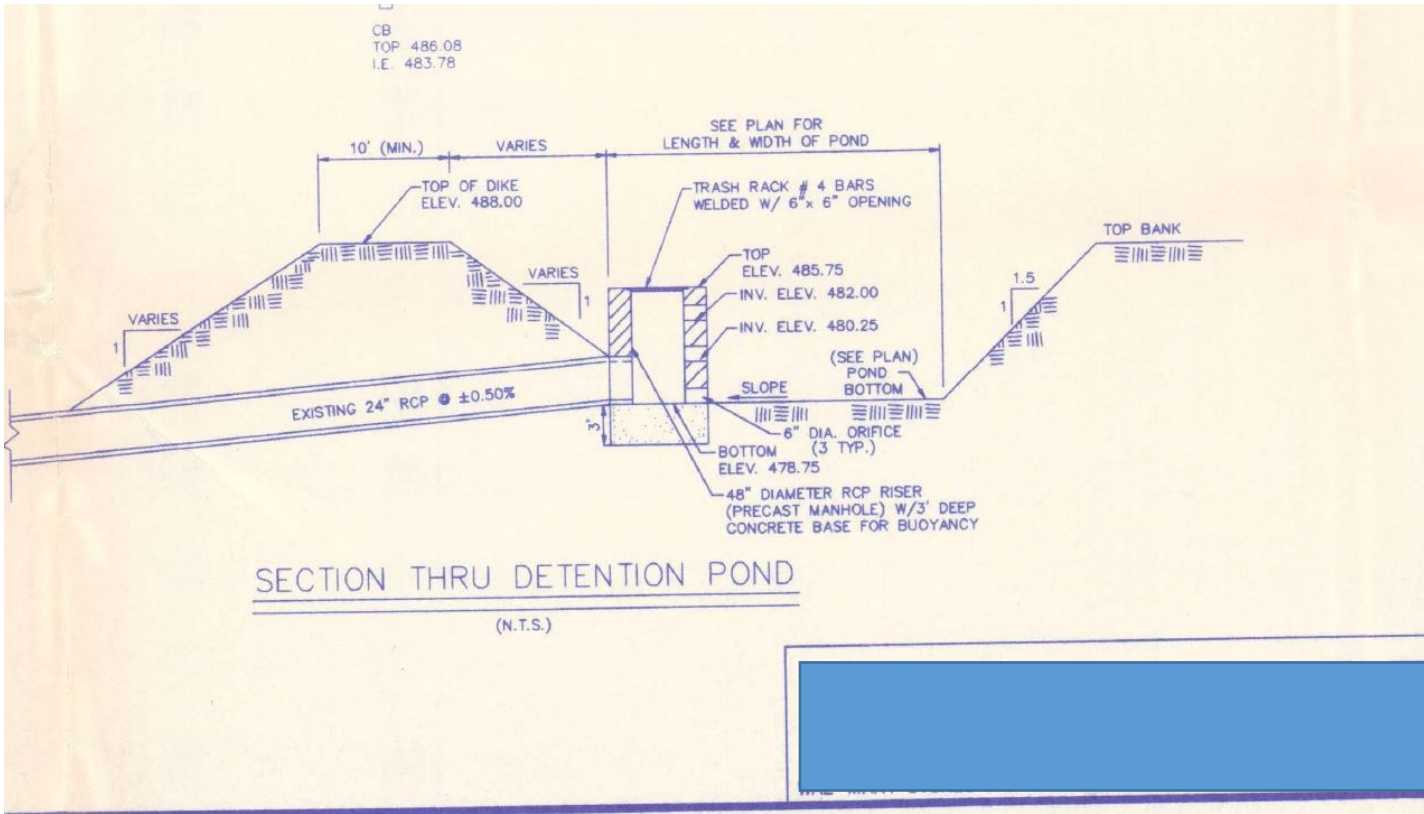

Rear retaining wall detail

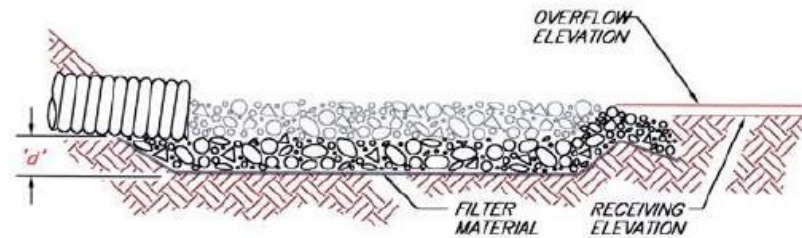

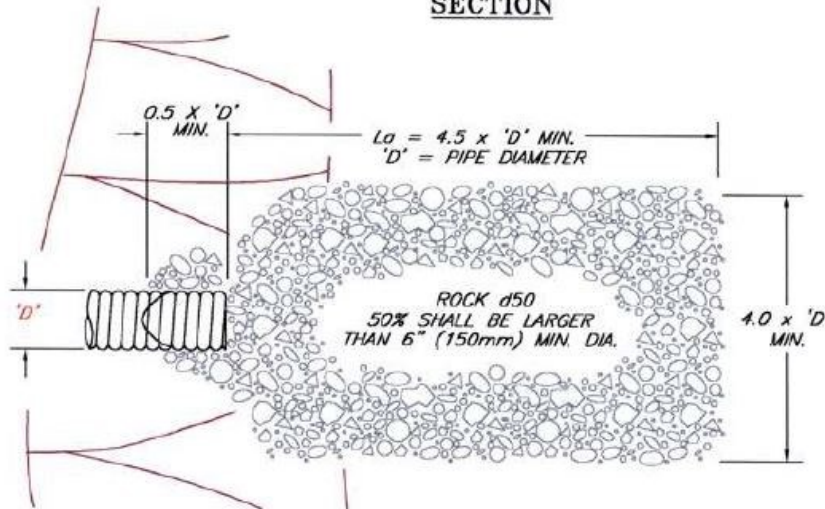
Planting Considerations:

- Seed should be planted at acceptable rates per SCDOT or by using the chart above.
- Seed should be drilled, harrowed, hydroseeded with a tackifier, or covered with mulch that is anchored by discing.
- If rainfall is not adequate, the area must be irrigated.
- For final stabilization, both temporary and permanent seed must be used.
