### RESOLUTION NO. 2020-12 <u>A RESOLUTION FINDING THAT ALL CONDITIONS</u> <u>PRECEDENT TO THE ISSUANCE OF NOT TO EXCEED</u> <u>\$10,250,000 GENERAL OBLIGATION BONDS HAVE BEEN</u> <u>MET AND DIRECTING THE AUTHORIZED OFFICERS TO</u> <u>EFFECT THE ISSUANCE OF SUCH BONDS; AND</u> <u>MATTERS RELATED THERETO.</u>

# BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH AUGUSTA, SOUTH CAROLINA, IN MEEETING DULY ASSEMBLED:

### Section 1 Findings of Fact.

WHEREAS, the City Council (the "City Council") of the City of North Augusta, South Carolina (the "City"), pursuant to Ordinance No. 2018-07 of the City Council (the "Ordinance"), ordered a bond referendum to be held in the City of North Augusta on November 6, 2018;and

WHEREAS, the Boards of Voter Registration and Elections of Aiken County and Edgefield County conducted a referendum in the City in accordance with the Ordinance on November 6, 2018 (the "Bond Referendum") where a ballot question regarding authorization for the City to issue not exceeding \$10,250,000 of general obligation bonds (the "Question") was submitted to the qualified electors of the City; and

WHEREAS Section 1.01(9) of the Ordinance conditions the issuance of any bonds under the Ordinance upon both (1) a favorable referendum pursuant to the Capital Projects Sales Tax Act (the "CPST Referendum") as evidenced by the declaration of the result of the County Council of Aiken County, South Carolina pursuant to Section 4-10-330(F) of the Capital Project Sales Tax Act, and (2) a favorable Bond Referendum; and

WHEREAS, the CPST Referendum in the County resulted favorably as declared by the County Council of Aiken County by resolution adopted November 13, 2018, and attached hereto as Exhibit A; and

WHEREAS, the Bond Referendum in the City resulted favorably to the Question as set forth in City Resolution 2018-27 dated November 19, 2018.

### Section 2 Finding and Direction Pursuant to Section 1.01(9) of the Ordinance.

City Council hereby finds that the conditions of Section 1.01(9) of the Ordinance have been met and directs the Authorized Officers (as defined in the Ordinance) to proceed to issue the Bonds or BANs authorized under the Ordinance.

### Section 3 Effective Date.

This resolution shall be effective on the date of adoption hereof by City Council.

### RESOLUTION NO. 18-11-178

### COUNCIL ADMINISTRATOR FORM OF GOVERNMENT FOR AIKEN COUNTY

To Declare the Results of a Referendum Held on November 6, 2018, in Aiken County, South Carolina, for the Purpose of Determining Whether or Not a One Percent Sales and Use Tax Should be Reimposed in Aiken County for Not More than Seven Years, the Proceeds of Which Would be Expended for Specified Capital Improvements Pursuant to the Capital Project Sales Tax Act and Aiken County Ordinance number 18-07-23.

- 1. The Aiken County Council has received a certification of the Registration/Elections Commission for Aiken County certifying that a Referendum was conducted on November 6, 2018, in Aiken County, South Carolina, for the purpose of determining whether or not a one percent sales and use tax should be reimposed in Aiken County for not more than seven years to raise funds to be expended for certain specified capital improvements in Aiken County, which election resulted favorably on the question of the reimposition of such sales and use tax pursuant to the Capital Project Sales Tax Act, and
- 2. The Aiken County Council has reviewed the proceedings and actions taken by the Registration/Elections Commission for Aiken County in order to ascertain that the Referendum on the imposition of a one percent sales and use tax was duly and properly held and conducts; and
- 3. S.C. Code Ann. Section 4-10-330(F) provides that after a referendum conducted under the Capital Project Sales Tax Act, the County governing body must declare the results of the referendum by adoption of a resolution.

NOW THEREFORE BE IT RESOLVED BY THE AIKEN COUNTY COUNCIL THAT:

- 1. As an incident to the adoption of this Resolution, the Council finds that the facts set forth in the recitals hereof, as the preamble hereto, and the statements therein made, are true and correct.
- 2. A Referendum was held in the area of Aiken County, South Carolina, on November 6, 2018, as authorized by Aiken County Ordinance Number 18-07-23, at which the following question was presented to the qualified electors of Aiken County:

Must a special one percent sales and use tax be reimposed in Aiken County for not more than seven (7) years to raise the amounts specified for the following purposes:

- I. The first \$5,949,866 received by Aiken County under the Capital Project Sales and Use Tax shall be distributed, subject to the procedures set forth in an ordinance adopted by County Council, to the following municipalities in the priority such municipality is listed below:
  - A. \$1,833,612 for the following projects within the **Town of Burnettown**, such projects to be funded in the order determined by Burnettown Town Council:

\$500,000 for water line and tank upgrades;

\$200,000 for equipment for the Water Works Department;

\$200,000 for police car replacement, upgrades and police equipment;

\$100,000 for Water Works vehicle replacement and upgrades;

\$150,000 for Town Hall/Police Department upgrades and security;

\$120,000 for camera/security system for Town Hall, courtroom, Police Department, Museum, Sassafras Park, computer upgrades;

\$100,000 for emergency generator for water wells;

\$100,000 for equipment and equipment storage to maintain Town parks;

\$200,000 for Community Center/Town Hall signage and office upgrades;

\$100,000 for Parks and Recreation renovations including purchasing, removing and installing signage, fencing, concessions and improvements to Willie Whaley Park;

\$63,612 for maintenance shop upgrades.

B. \$1,064,868 for the following projects within the **Town of Jackson**, such projects to be funded in the order determined by Jackson Town Council:

\$125,000 for police vehicles, equipment and infrastructure;

\$339,868 for water department vehicles, equipment and infrastructure;

\$305,000 for fire department vehicles, equipment and building improvements;

\$90,000 for Municipal Buildings and grounds improvements;

\$65,000 for sanitation equipment and vehicles;

\$85,000 for street maintenance equipment, landscaping and signage;

\$35,000 for park improvements and equipment;

\$20,000 for property purchase and improvements for economic development.

C. \$76,868 for the following projects within the **Town of Monetta**, such projects to be funded in the order determined by Monetta Town Council:

\$25,000 for playground equipment;

\$25,000 for a backhoe;

\$25,000 for equipment shed and fencing;

\$1,868 for Community Center renovations.

D. \$1,548,584 for the following projects within the **City of New Ellenton**, such projects to be funded in the order determined by New Ellenton City Council:

\$258,584 for public works vehicles and equipment and facility improvements;

\$350,000 for sewer plant rehabilitations, installation of new sewer lines, long-term right-of-way maintenance and upkeep, development of as-built drawings and grant match;

\$30,000 for Community Center upgrades;

\$300,000 for police equipment, vehicles and call stations;

\$160,000 for an announcer's booth, concession stand, playground equipment and tennis court for recreation;

\$420,000 for stormwater infrastructure improvements, street resurfacing, sidewalk construction and vehicles for streets department;

\$30,000 for fire department vehicle.

E. \$118,611 for the following projects within the **Town of Perry**, such projects to be funded in the order determined by the Perry Town Council:

\$45,000 for water service vehicle;

\$55,000 for walking track lighting;

\$10,000 for computer upgrades to integrate with meter reading system;

\$8,611 for security system in Town Hall.

F. \$235,556 for the following projects within the **Town of Salley**, such projects to be funded in the order determined by the Salley Town Council:

\$5,000 for backhoe attachment for tractor;

\$6,000 for new commercial lawn mower;

\$155,056 for renovations to the civic center,

\$35,000 for electrical and water upgrades to the festival vendor area;

\$15,000 for emergency generators;

\$4,500 for Town Hall improvements and upgrades;

\$15,000 to replace a Town pickup truck.

G. \$984,240 for the following projects within the **Town of Wagener**, such projects to be funded in the order determined by Wagener Town Council:

\$350,000 for water/sewer system infrastructure upgrades and improvements;

\$284,240 for Town park and facility improvements, including improved lighting;

\$100,000 for vehicle and equipment replacement for the police department;

\$50,000 for improvements and renovations of the fire department;

\$200,000 for new construction and/or renovations of Town Hall.

H. \$87,527 for the following projects within the **Town of Windsor**, such projects to be funded in the order determined by Windsor Town Council:

\$65,000 for renovations of Town Hall,

\$22,527 for renovations and repair of recreation park.

- II. The next \$156,910,819 received by Aiken County under the Capital Project Sales and Use Tax shall be distributed proportionally, subject to the procedures set forth in an ordinance adopted by County Council, among the following three jurisdictions in the percentages shown: The City of North Augusta (18.88%), the City of Aiken (31.23%), and Aiken County (46.24%) for the following projects:
  - A. \$30,700,000 for the following projects for the **City of North Augusta**, such projects to be funded the order determined by North Augusta City Council:

\$11,500,000 for design, development and construction of a new Department of Public Safety headquarters station and related fire apparatus;

\$2,000,000 for Martintown Road/US 1 intersection design and improvements;

\$300,000 for downtown pedestrian and vehicular traffic safety improvements;

\$700,000 for placing utilities underground along Georgia Avenue;

\$3,000,000 for reconstruction of the following City of North Augusta roads:

Bluff Avenue East Pine Grove Avenue Yardley Drive Canary Road Wren Road Vireo Road Trimmier Place Lowe Street Towhee Avenue Briggs Avenue

\$1,450,000 for resurfacing of the following City of North Augusta roads:

Amy Circle Bolin Court Bolin Road Cadada Court Calbrieth Circle Calbrieth Way Cascade Drive Clifton Avenue Edgewood Avenue Edgewood Court Hastings Place Leyland Place Medie Avenue Mill Branch Way Mokateen Avenue Northwood Court Old Walnut Branch Pine Grove Avenue Raborn Court Shawnee Drive Spring Grove Avenue St. Julian Place Walnut Grove Drive.

Council accordingly hereby declares that the results of the Referendum resulted in the approval of the question of the reimposition of a one percent sales and use tax in Aiken County for not more than seven years to raise funds to be expended for capital improvements as stated in the Referendum question.
