

INVITATION FOR PROPOSALS – CITY OF NORTH AUGUSTA

The City of North Augusta will receive written proposals for the purpose of **Land Surveying Services for the Proposed North Augusta Greenway Extension**.

Proposals must be submitted by 11:00 a.m. on Thursday, April 15, 2021 to the address below. At that time all proposals will be publicly opened and read. Bids will be reviewed for price, qualifications and ability to begin the work within 30 days of award.

The City of North Augusta is seeking a lump sum proposal from South Carolina licensed professional land surveying firms to provide survey services for the City. Bidders must provide a brief professional statement of qualifications; a bid for the work; and a time-frame including start of work and completion of work. All bidders must be licensed surveying professionals that have the ability and licensure, insurance and capacity to complete the type of work described.

Description of Work:

1. A topographic and planometric survey of a ± 50 foot wide strip along the center line of proposed trail as shown on the map on page 3. The strip totals approximately 0.75 acres and is located in the Woodstone Subdivision, off Rippling Creek Lane in North Augusta. The property is old railroad right of way that the City is planning to use to construct an extension to the Greenway.
2. A topographic survey is to be prepared and submitted to the city in digital format showing property lines, bearings and distances, 1' contour lines, and any existing improvements (dams, structures, inlets, outlets, conveyances, and utilities) within the boundary of the property. Provide spot elevations of pipe inlets/outlets, manhole tops, etc. The survey should also note any trees over 6" in caliper. If any encroachments exist within the boundary, the survey will show that, with distances and boundaries of the encroachments.
3. Staking and flagging property corners and property lines located within clear sight distances that are visible to persons working in the area.
4. Resetting on any missing pins to ensure all property lines are clear and visible.
5. Final deliverables shall consist of a digital AutoCAD 2013 or newer version of the survey in state plane coordinates on USB Flash Drive or CD.

The City reserves the right to reject any or all bids, and parts of any bid, and to waive formalities and technicalities. To be entitled consideration, each bidder must be legally

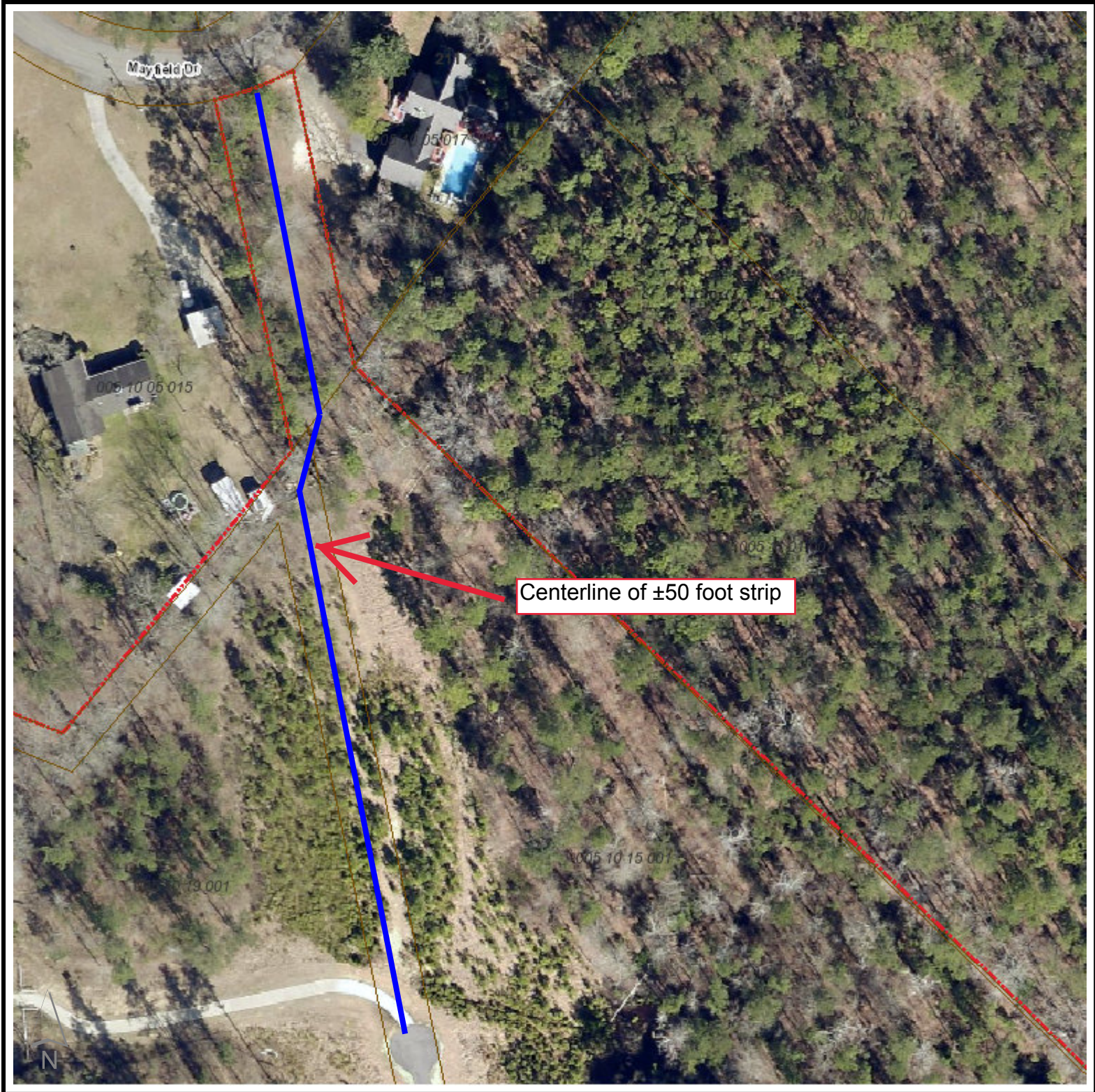

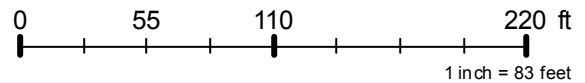
