
ITEM 1. CITY COUNCIL AGENDA: Items on the March 15, 2021 Council Agenda- Council Discussion

ITEM 2. PLANNING AND DEVELOPMENT: West Martintown Road Corridor Study and Planning Commission Recommendation – Council Discussion

Libby Hodges, Director of Planning and Development, and Ryan Eckenrode, Project Manager, Senior Traffic Engineer with AECOM, led Council in a discussion of the West Martintown Road Corridor Study and Planning Commission Recommendation. The top five priorities suggested by the Planning Commission were discussed. Mr. Eckenrode stated that citizen comments, safety, and SCDOT regulations were among the considerations for the priorities. Ms. Hodges commented public comments are still being accepted and will continue to be accepted up until the time Council acts on the study. Council received a copy of the study and recommendation at the March 1, 2021 regular City Council meeting. 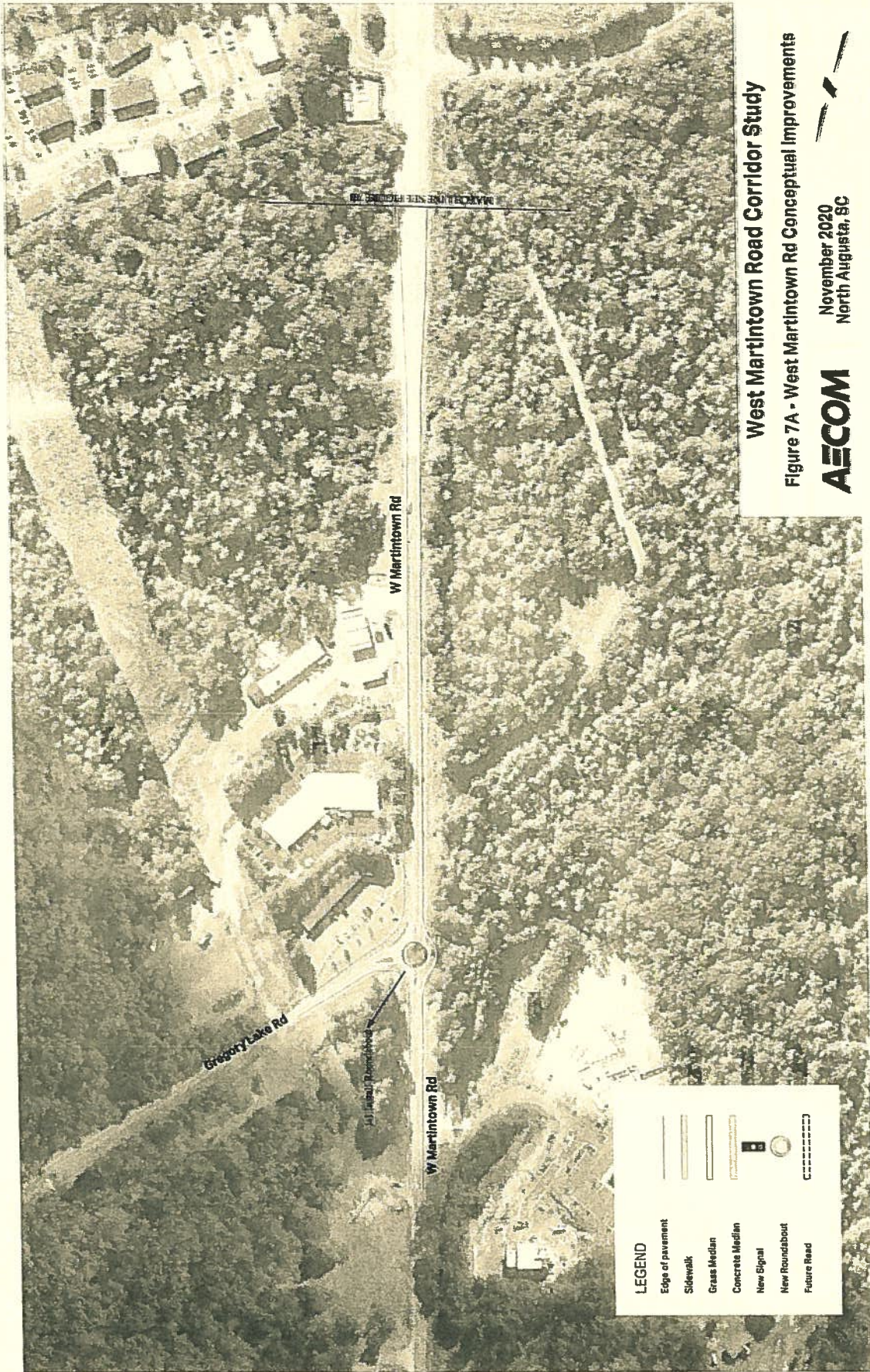

Figure 7A - West Martintown Rd Conceptual Improvements

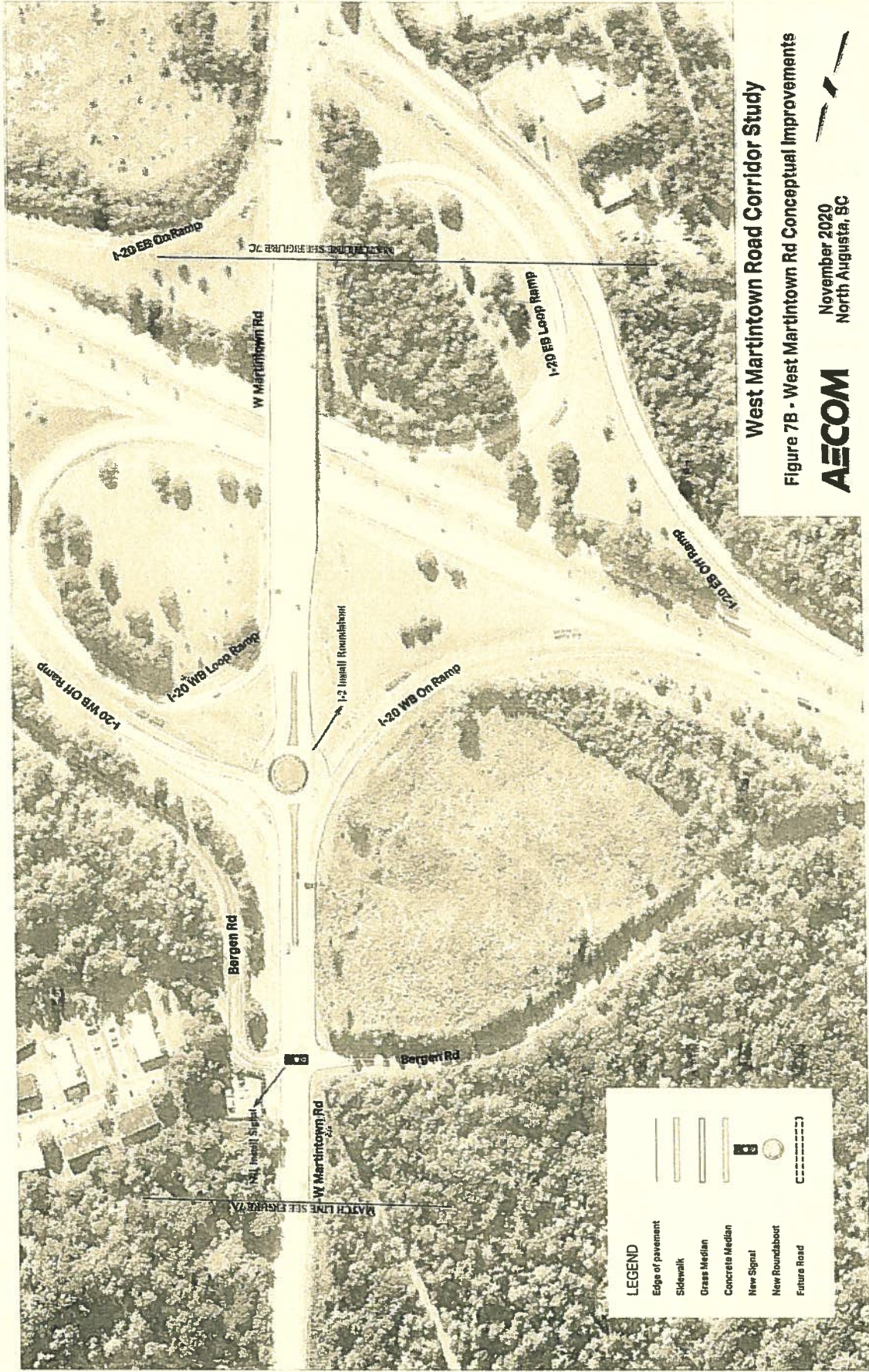
