ORDER OF BUSINESS

SPECIAL CALLED CITY COUNCIL MEETING

The Special Called City Council meeting of August 9, 2021 for the City of North Augusta, having been duly publicized, was called to order by Mayor Pro Tem Brooks at 6:00 p.m. and also streamed online for public viewing at the City Facebook page: "City of North Augusta – Public Information" and City YouTube page: "City of North Augusta Public Information." The Special Called City Council meeting adjourned 6:14 p.m.

Per Section 30-4-80(e) notice of the meetings was sent out by email to the current maintained "Agenda Mailout" list consisting of news media outlets and individuals or companies requesting notification. Notice of the meetings was also posted on the outside doors of the Municipal Center, the main bulletin board of the Municipal Center located on the first floor, and the City of North Augusta website.

Members present were Mayor Pro Tem Brooks, Councilmembers Carpenter, McCauley, McGhee, Presnell, and Toole. Mayor Williams was absent.

ITEM 1. ENGINEERING AND PUBLIC WORKS: Resolution No. 2021-33 — A Resolution Authorizing a Supplemental Inspection Services Contract for the Building Standards Department

On the motion of Councilmember Carpenter, second of Councilmember Presnell, Council agreed to consider a resolution to authorize a Supplemental Inspection Services Contract for the Building Standards

Department. Rachelle Moody, Assistant City Administrator, explained this proposed contract would be effective through 2021. There were no comments from citizens. Council approved the resolution with a unanimous vote of 6-0.

RESOLUTION NO. 2021-33

A RESOLUTION AUTHORIZING A SUPPLEMENTAL INSPECTION SERVICES CONTRACT FOR THE BUILDING STANDARDS DEPARTMENT

WHEREAS, on November 2, 2020, City Council adopted a balanced budget for the fiscal year beginning on January 1, 2021, and ending on December 31, 2021 which included three Inspectors in the Building Standards Department effective January 1, 2021; and

WHEREAS, City staff has identified an upcoming delay in inspection services due to a medical leave of absence; and

WHEREAS, City staff has identified budgeted personal services expenses and operating expenses savings in the General Government function as well as surplus revenue from construction related permits sufficient to enter into a supplemental inspection services contract for an amount not to exceed \$15,000; and

WHEREAS, there are various firms with South Carolina State On-Call Contracts offering the type of services that are applicable to the City; and

WHEREAS, Administration supports the supplemental inspection services contract to meet the Building Standards Department's staffing needs; and

WHEREAS, City Council believes it to be in the best interest of the City to contract for supplemental inspection services to support staffing needs of the Building Standards Department.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of North Augusta, in meeting duly assembled and by the authority thereof, that a contract be entered into for supplemental inspection services with charges not to exceed \$15,000 to be charged to professional services in the Building Standards Department of the General Fund.

BE IT FURTHER RESOLVED that the City Administrator and/or Director of Public Works shall be authorized to sign all documents relating to the identified contractual services.

ITEM 2. PARKS, RECREATION AND TOURISM: Ordinance No. 2021-11 – Authorizing a Restructuring of Personnel for the Department of Parks, Recreation, and Tourism Subsequent to Department Vacancies Resulting from Retirements and Resignations; Ordinance – First Reading

On the motion of Councilmember McCauley, second of Councilmember Toole, Council agreed to consider an ordinance on first reading authorizing a restructuring of personnel for the Department of Parks, Recreation, and Tourism subsequent to department vacancies resulting from retirement and resignations. There were no citizen comments. Council unanimously approved the first reading of the ordinance with a 6-0 vote.

ORDINANCE NO. 2021-11

AUTHORIZING A RESTRUCTURING OF PERSONNEL FOR THE DEPARTMENT OF PARKS, RECREATION, & TOURISM SUBSEQUENT TO DEPARTMENT VACANCIES RESULTING FROM RETIREMENTS AND RESIGNATIONS

WHEREAS, in accordance with the Laws of South Carolina, and the Ordinance of the City of North Augusta, the City Administrator prepared and submitted to the City Council a Balanced Budget for the budget year beginning on January 1, 2021, and ending on December 31, 2021 which was adopted November 2, 2020; and

WHEREAS, the City has determined that a restructuring of personnel for the Department of Parks, Recreation, & Tourism ("Department of PRT") is necessary to expand upon opportunities resulting from department vacancies from retirements and resignations and to continue to provide adequate services related to activities of the Department; and

WHEREAS, this restructuring is to be done within the authorized total appropriations for personal services expenses of the Department of PRT as adopted by City Council on November 2, 2020.

NOW, THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH AUGUSTA, SOUTH CAROLINA, IN MEETING DULY ASSEMBLED AND BY THE AUTHORITY THEREOF, THAT:

Section I.

The City Council hereby authorizes a restructuring of personnel for the Department of PRT as follows with proposed Department of PRT organizational chart attached as Exhibit A:

effect.


Section III. All Ordinances or parts of Ordinances in conflict herewith are, to the extent of
