## <u>RESOLUTION NO. 2022-47</u> <u>A RESOLUTION AUTHORIZING THE ACCEPTANCE OF BID OF</u> <u>AXON ENTERPRISES, INC. FOR THE</u> <u>LIFE CYCLE REPLACEMENT OF PUBLIC SAFETY OFFICER BODY CAMERAS</u>

WHEREAS, The City received a bid quote for updated Axon body cameras for Public Safety Officers at a discounted rate which expires after 30 September 2022; and

WHEREAS, the City Administrator proposed a draft Fiscal Year 2023 budget which includes funding for Axon body camera system maintenance on September 26, 2022; and

WHEREAS, the City Fiscal Year 2023 budget has not yet been approved via ordinance; and

WHEREAS, the Mayor and City Council of the City of North Augusta find that the awarding of such bid prior to September 30<sup>th</sup> is in the best interest of the City based on the cost savings of \$81,835 over the life of a five year contract; and

WHEREAS, the City has sufficient funds available in the Capital Projects Fund should the Fiscal Year 2023 budget not include funding for body cameras; and

NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council of the City of North Augusta, South Carolina, in meeting duly assembled and by the authority thereof that AXON Enterprise, Inc. shall be awarded the contract for the Public Safety body camera systems for a total amount of \$305,802.75 over a five year period.

BE IT FURTHER RESOLVED that the funding sources for this contract shall be from the Fiscal Year 2023-2027 budgets if passed, with funding from the Capital Projects Fund to be allocated if this line is removed from the Fiscal Year 2023 or later budgets.

BE IT FURTHER RESOLVED that the City Administrator is authorized to execute any documents required for the entering into of this contract.
