Vendor requests for payments shall be submitted by invoice and include; City of North Augusta purchase order number, invoice number and itemized materials and any shipping cost.

The City of North Augusta reserves the right to add or reduce the quantities without a reduction in unit price.

II. Specifications

Residential Recycling Bins shall meet the minimum requirements set forth as follows:

1. Be rated, at a minimum, at an 18-gallon capacity.
2. Manufactured with high-density polyethylene resin with ultra violet stabilizers.
3. Minimum wall thickness of 100 mil.
4. Have contoured corners and edges for safety and strength.
5. Rounded built in handles designed for ease of handling and transport.
6. Drain holes to remove rainwater.
7. Stackable.
8. Not weight more than 4.5 pounds.
9. Color medium shade of blue.
10. City's logo hot stamped on each side of the bin.

Statement of Warranty

A statement of Warranty shall include all applicable manufacturers' warranty and the Vendors warranty in regards to materials and workmanship. This statement shall include the term, conditions and the period of warranty coverage. Any exclusion(s) must be clearly stated.
