ONE-CENT SALES TAX

When voters go to the polls on November 7, 2000, they will for the first time have an opportunity to say "YES" or "NO" on a countywide One-Cent Capital Projects Sales Tax.

For many years residents of North Augusta and Aiken County have paid this one-cent tax when shopping in Augusta/Richmond and Columbia Counties. The one-cent tax has been a boon to those two Georgia counties for building roads, improving drainage and providing first class recreation facilities.

When approved for Aiken County, citizens will see for the first time more than \$54 million generated and used for needed road improvements, drainage projects and recreational facilities at home throughout the City and County. These projects have been specifically identified and will be listed on the November ballot.

ONE-CENT CAPITAL PROJECTS

On November 7, 2000 voters of Aiken County will go to the polls to decide on a One-Cent Capital Projects Sales Tax for North Augusta and Aiken County. The one-cent sales tax will have a significant economic impact on the citizens of North Augusta over the next seven years. The increase will change the countywide sales tax from five cents to six cents on all retail sales except for food preparation. This is a penny less than in Augusta/Richmond County or Columbia Counties across the river in Georgia. Proceeds from the One-Cent Capital Projects Sales Tax will generate more than \$54 million and will support the largest local road and drainage improvement program and recreation facility development program in Aiken County in the history of the County.

Last May Aiken County Council appointed a six-member Capital Projects Sales and Use Tax Commission to identify and assess needed projects from throughout Aiken County. City Council member Kent Sullivan represented the City of North Augusta on the Commission. In July the Commission submitted its report to County Council with a lengthy list of much-needed projects along with a recommendation that the Aiken County Council submit the question of a One-Cent Capital Projects Sales Tax to the voters on the November general election ballot.

Several members of the Capital Projects Sales Tax Commission and citizens of Aiken County stated that the One-Cent Capital Projects Sales Tax would allow the County and the towns and cities within the County to complete important projects that might never be completed otherwise.

When approved by the voters on November 7, the one-cent sales tax will go into effect on May 1, 2001. By state law the one-cent sales tax will end 7 years later. If the total amount of funds designated on the referendum, \$54,600,000, is collected before the end of 7 years or if all of the listed projects have been completed before the end of the 7 years, the tax will end earlier.

All of the projects to be funded from the one-cent sales tax are specifically listed on the ballot. Detailed listings of specific streets, drainage and recreation projects to be funded in North Augusta are listed on the following pages.

When Aiken County voters say "YES" to a One-Cent Capital Projects Sales Tax in November, the anticipated \$54.6 million generated by the tax for the many needed projects may actually be a great deal more. By using locally generated funds from the one-cent sales tax as a match, many state and federal sources of funds can be tapped.

For Phase I of the Bobby Jones Expressway extension into South Carolina, \$15 million will be generated locally. This represents only 28% of the total funds required for this phase. An additional \$38 million will be generated from state and federal sources.

For street resurfacing and drainage projects within the City, local sales tax funds will be paired with annual appropriations from State sources to expand the list of roads requiring resurfacing or drainage improvements. Over the seven year life of the one-cent sales tax an additional \$1.4 million can be anticipated from the state.

North Augusta is often eligible for state and federal funding to expand ever popular and much-in-demand recreational facilities if local funds are available for matching. Many times these programs are matched 80% if the local 20% is available. Proceeds from the one-cent sales tax will be targeted to obtain these matches.



NORTH AUGUSTA Capital Projects

The City of North Augusta is slated to receive \$7,522,903 over the seven year life of the One Cent Capital Projects Sales Tax. These are the projects to be funded.

Hospitality lax

The City Council has reduced the local hospitality tax in North Augusta from two-cents to one-cent. The cut will be effective with the passage of the countywide One-Cent Capital Projects Sales Tax. This action assures the restaurant and food preparation businesses in North Augusta of no increase in the tax level.

In 1999, the City adopted a two-cent Hospitality Sales Tax on all prepared foods sold in North Augusta. Proceeds from the tax go directly into downtown and riverfront redevelopment projects. Total sales tax on this industry is seven cents and equal to sales tax levels in Augusta/Richmond and Columbia Counties.

In adopting the reduction, City Council stated its intent to assure the hospitality industry that a customer would not pay more sales tax in North Augusta than the seven cents in surrounding areas. To back up their pledge, City Council adopted the one-cent reduction in the hospitality tax beginning with the effective date of a voter approved One-Cent Capital Projects Sales Tax, May 1, 2001. The reduction would remain in effect as long as the One-Cent Capital Projects Sales Tax is in place.

Last August work began on the long delayed construction of Phase I of the Downtown Streetscape Project, improvements to Georgia Avenue between the Greeneway and Jackson Avenue. The delay in construction was due to changes in design required by the South Carolina Department of Transportation. After substantial revisions to the original plans SCDOT issued the permit for construction. Beam's Pavement Maintenance Company, Inc., of Beech Island was awarded the contract for the roadway improvements. CH2M Hill, Inc., a national engineering firm, was retained by the City to serve as Construction Manager for the project. CH2M Hill will be responsible for inspecting completed work, monitoring and maintaining the construction schedule, and ensuring that work conforms to the approved construction plans.

GREENEWAY BRIDGE Receives Vational Hward

The North Augusta Greeneway Bridge was one of only seven trail projects in the country to receive an Achievement Award from the National Coalition for Recreational Trails this year. North Augusta was noted for outstanding use of Recreational Trails Program Funds.

The Recreational Trails Program returns a portion of federal taxes paid on fuel used in off-highway recreation vehicles to each of the fifty states for development and maintenance of recreational trails. The Coalition for Recreational Trails is a federation of national and regional trail-related organizations whose mission is to build public awareness and understanding of the Recreational Trails Program.

The South Carolina Department of Parks, Recreation and Tourism (SCPRT) encouraged the North Augusta Department of Parks, Recreation and Leisure Services to apply for the award. The Greeneway's 180-foot arch-truss pedestrian and bicycle bridge spanning West Martintown Road was funded in part with Recreational Trails Program Funds through SCPRT. Recreational Trails Program Funds provided \$200,000 of the \$262,500 cost of the bridge. The South Carolina Department of Transportation contributed \$50,000 through the Transportation Enhancement Program and the City provided the \$12,500 balance.

The installation of medians in the center of Georgia Avenue from the Greeneway to Clifton Avenue was the first work completed. Asphalt was removed and replaced with curb, gutter and raised beds for landscaping. A portion of the roadway between Buena Vista and Pine Grove Avenues has been milled to remove layers of old asphalt pavement. After the new curb and gutter has been constructed new asphalt pavement will be installed in the roadway. Cold Creek Nurseries will install the new landscaping and irrigation in the medians and on each side of the street after Beam's completes each block.

The construction schedule calls for the contractor to work in one block at a time to minimize disruption. Additionally, access to all businesses will be maintained, one lane of traffic in each direction will remain open and at least half of the onstreet parking will be available at all times.

The vacant lot on the corner of Bluff and Georgia Avenues, the old Downtown Motel property, will be used by the contractors to store construction materials and equipment until the Streetscape Project is complete. The former Chamber of Commerce building on the corner of Clifton and Georgia Avenues is being used as an office for the contractors and the construction manager. At the completion of construction the old Chamber building will be removed and a small park overlooking the City's historic Waterworks Park area will be developed.




ton who stated, "Tim is typical

BE Be Fire Smart RT'

The Department of Public Safety urges everyone to be "Fire Smart" this fall. The following fire safety tips, along with common sense and good judgment, can help you avoid injury and property damage.

— Outdoor Burning

- Before burning contact the Department of Public Safety for burning regulations and restrictions and apply for any permits that may be required.
- Always clear an 8 to 10 foot circle around the burning site, away from any nearby shrubs and overhanging tree branches.
- Always have a good water source or fire extinguisher handy to extinguish the fire quickly and completely.
- · Never burn on windy days.
- · Never leave a fire burning unattended.

— Home Fire Safety ———

- Install and maintain smoke alarms near or inside bedrooms and on every floor or level of your home.
- Test all smoke alarms monthly and change the batteries at least once a year. A good way to remember to change the batteries is to change them when you re-set your clock for daylight savings time. New 10-year smoke detectors, which use lithium batteries and range in cost from \$5 to \$30, can be found at most hardware and discount stores.
- Practice different ways to get out of the house in case of a fire. Every member of the family should agree on a safe place to meet outside the house in the event of a fire.
- Do not smoke inside your home.
- Make sure everyone in your family knows the STOP, DROP, and ROLL procedure in case their clothes catch on fire.

PUBLIC SAFETY DEPARTMENT Seeks Accreditation

For the past two years the North Augusta Department of Public Safety has been evaluating and revising its policies, practices and procedures toward the goal of achieving the distinction of South Carolina Law Enforcement Accreditation.

The local law enforcement accreditation and certification process was initiated in South Carolina in 1997 to recognize that the highest standards of law enforcement are being met. The goal of the accreditation process is to help local law enforcement agencies strengthen crime prevention and control capabilities, formalize management procedures, establish fair and non-discriminatory personnel practices, improve service delivery, solidify interagency cooperation and coordination, and boost citizen and staff confidence in the agency.

The benefits of Law Enforcement Accreditation to the community are numerous. Benefits can include controlled liability insurance costs; fewer citizen complaints, improved defense against lawsuits, greater agency accountability, increased community confidence, and access to the latest expert law enforcement methods.

Four Law Enforcement Agencies in South Carolina have received Certificates of Accreditation after a two year evaluation process. Twenty-seven agencies, including the North Augusta Department of Public Safety, have applied. North Augusta expects to receive its Certificate of Accreditation in early 2001.

- Keep matches and lighters out of reach of children.
- Always leave at least three (3) feet of space around a space heater and always unplug it when not in use.
- If you have a fireplace in your home, have your spark arrester checked and your chimney inspected for soot build-up before use each year.



- Never use a grill or charcoal product indoors. Burning charcoal produces carbon monoxide, a colorless, odorless gas that can cause death or permanent injury.
- Position grills at least ten (10) feet away from all structures.
- Never use a grill in a garage, breezeway, carport, porch, or under a cover or tree branch that may catch fire.
- · Always have the grill lid open when lighting.
- Never move a grill that has been lit and is in use.
- After use, make sure that the hot coals from the grill are in a safe location and not allowed to come in contact with anything that will burn. Charcoal embers can smolder for several days.



- Common fireworks available to the public are explosives and must be handled with extreme care. Each year thousands of people suffer injuries or property damage as a result of improper care and handling of fireworks.
- Always clear away any flammable materials from the area before igniting any fireworks.
- Always have a fire extinguisher or good water source readily available to extinguish an unexpected fire.
- Never shoot fireworks from a metal or glass container.
- Always supervise children with fireworks.

POLICE YEHICLES -Reflect New Image

The Department of Public Safety patrol cars are sporting a new look. Recently the marking for patrol vehicles was redesigned to incorporate the City's new logo and, more importantly, meet South Carolina Law Enforcement Accreditation Standards. One of the standards for accreditation requires that marked patrol vehicles be conspicuously marked for both day and night visibility on both sides and the rear of the vehicle. The 911 emergency number must also be present and prominently displayed for easy day and night visibility. The new, predominantly green marking includes the South Carolina State outline on each front fender. The words "South Carolina's Riverfront" are written within the state border. The word "Police" and the 911 emergency telephone number dominate the new marking and are applied in a highly reflective material.



Banacom Instant Signs created the new marking design with direction from the Department of Public Safety. The contract for striping the vehicles was awarded to Communigraphics. The cost to apply the new vehicle marking is less than the previous striping pattern. Seven new and previously unmarked vehicles have been striped with the new design. The new marking will be applied to all new vehicles as older patrol cars are replaced.

HOLIDAY SANITATION Schedule Changes

North Augusta provides once-a-week curbside collection of garbage, yard waste, trash and recyclables for all residential properties in the City. Normal collection days are Monday through Thursday with a specific day assigned to each neighborhood. The collection schedule is adjusted in weeks that contain a holiday. Holidays for the balance of the year and the adjusted collection days are:

Thanksgiving Holidays Thursday, November 23 & Friday, November 24

Christmas Holiday Monday, December 25

New Year's Holiday Monday, January 1

Thursday's collection will be picked up on Wednesday, November 22. All other collection days remain the same.

All collections during the week of December 25 will be delayed one day.

All collections during the week of January I will be delayed one day.
