

The North Augusta City Council has approved the purchase of a majority of property in the 196 acre Central Riverfront Redevelopment District. Detailed plans for the Riverfront District, originally approved in 1996 and updated in 2000, include the 1½ mile Greeneway Extension, a riverfront park and amphitheater, a 150 room hotel and conference center, 575 residential units and approximately 300,000 square feet of commercial space including shops, restaurants and offices. The Central Riverfront Redevelopment District extends from the James U. Jackson Memorial (13th Street) Bridge approximately a mile upstream between the Greeneway and the Savannah River. The City will develop the Greeneway Extension, Riverfront Park and other public amenities providing public access to the Savannah River. A private developer will construct the commercial and residential elements of the plan.

In 1999 the City acquired several small parcels totaling approximately ten acres adjacent to the current Greeneway alignment. In June the City bought a 2.5 acre parcel and approved the purchase of the 140 acre Churchill tract. In July an agreement was signed to acquire another 25 acres. The remaining 18.5 acres are comprised of several small parcels and negotiations are currently proceeding to purchase that land.

Funding for the land acquisition is provided by a variety of sources. A substantial portion of the City's investment will be recaptured through the sale of property not needed for the Greeneway and other public improvements to a private developer. The City's Riverfront Redevelopment Fund, tax increment revenues, capital projects funds, hospitality and accommodations taxes, state and federal grants and the Aiken County Capital Projects Sales Tax will all be utilized to finance portions of the acquisition and development of the Central Riverfront.

CENSUS DATA RELEASED

The U.S. Census Bureau recently released the results of the 2000 Census. The table summarizes information provided by citizens completing the Census Bureau's questionnaire last April and compares the City of North Augusta, Aiken County and the Aiken-Augusta Metropolitan Statistical Area (MSA). The Aiken Augusta MSA consists of Columbia, McDuffie and Richmond Counties in Georgia and Aiken and Edgefield Counties in South Carolina.

ADULT TRAFFIC SAFETY

The North Augusta Department of Public Safety has a history of commitment to traffic safety and has implemented several innovative traffic safety programs over the years. In the mid 1970's the Department initiated a traffic school for student first offenders of minor traffic violations. Young drivers charged with minor offenses can receive a not guilty verdict in municipal court after successfully completing the Department's traffic safety class. Additionally, no points are assessed against the driver's license and insurance rates are not usually affected. Since its inception the program has resulted in a repeat offender rate of only 13%.

Based on the success of the student program, the Department is expanding its traffic school to offer a similar program for adult first offenders. Like the student program, the adult program is designed to prevent further citations by educating first offenders on the importance of operating a motor vehicle in compliance with traffic laws. Eligible participants are individuals charged with a minor traffic offense in the City of North Augusta. Drivers charged with serious offenses including driving under the influence, driving under suspension, reckless driving, speeding more than 25 mph over the posted limit, operating an uninsured vehicle or leaving the scene of a traffic accident are not eligible for the program.

Drivers charged with a minor offense must apply for acceptance in the program. Selection is based on several standard criteria:

- The offender has received no other traffic citation from the North Augusta Department of Public Safety in the previous four years.
- The program application must be submitted and approved prior to the scheduled court date.
- The enrollment fee must be paid prior to the scheduled court date.

Enrollment fees have not yet been established. Applications will be available in the Public Safety Records Department on the lower level of the Public Safety Building in early August. Drivers who fail to attend class on the scheduled date will lose the enrollment fee and the original citation will be placed back on the court docket for trial. The Department plans to offer the Adult Traffic Safety Education Program monthly at Public Safety Station 2. Class size will be limited to 40 drivers.

DOWNTOWN STREETSCAPE

The Georgia Avenue phase of the Downtown Streetscape project, started last July, is in the final stages of construction. Improvements include a new roadway surface, landscaped medians, street trees, decorative streetlights, new traffic currently in the planning stage. This project will involve the renovation of West Avenue from Jackson Avenue to Clifton Avenue, including Spring Grove, Pine Grove and Buena Vista Avenues between Georgia and West Avenues. Many of

The Office of South Carolina Governor Hodges recently announced a \$25,000 Recreation Land Trust Fund grant to the City of North Augusta. The \$25,000 will be combined with funds from a variety of other sources to acquire land and develop the planned 1¹/₂ mile extension of the North Augusta Greeneway along the Savannah River. Funds from the Recreation Land Trust, administered by the South Carolina Department of Parks, Recreation and Tourism (SCPRT), require a 50 percent match and may only be used to purchase land for public recreation.

Last year the City received a 100,000 Recreation Trails Program grant from SCPRT that is also being used for the Greeneway riverfront extension.



Travelers on Georgia Avenue will soon notice another improvement in Downtown North Augusta. In addition to the new sidewalks, streetlights, pavement treatments and landscaping, custom banners decorated by local artists will be hung from the light poles. The art banners will hang from early August through late October and will then alternate with various holiday banners throughout the year.

An art banner Preview Party is scheduled for Thursday, August 16, from 5:30 p.m. to 7:30 p.m. at the North Augusta Community Center, 495 Brookside Drive. All are welcome to attend! The art banner project is sponsored by the North Augusta Cultural Arts Council and the City of North Augusta Department of Parks, Recreation and Leisure Services.

TO SC Kic Saj

Another school year will be starting soon and children will again be riding school buses every school day. Last year in the U.S., approximately 9,000 students were injured in incidents involving school buses. Twenty-six students were killed. To prepare for the start of another safe and productive school year, it is important for both children and adults to learn and remember several safety tips.

Drivers

- Do not speed. The speed limit in all school zones is 25 mph. Exceeding the speed limit dramatically increases the chance for an accident involving a child.
- Stay alert. When driving in and near school zones be alert for children walking or bicycling to school or waiting at bus stops.
- Stop for school buses loading and unloading children. When a school bus stops with its red flashing lights on, drivers on both sides of the road must stop and wait until the red lights stop flashing and the bus begins moving before driving again.

Students

- Stand back until the bus stops. When the bus approaches, stand at least three giant steps (about six feet) back from the curb and wait until the bus stops completely before stepping onto the bus.
- Cross in front of the bus. If you have to cross the street in front of the bus, walk on the sidewalk or along the side of the road past the front of the bus at least five giant steps (about ten feet) before you cross. Be sure you can see the bus driver and the bus driver can see you.
- Look both ways. Always look left, right and left again before you cross the street.
- Check before you step. When getting off the bus, look back before you step off the bottom step to be sure that your backpack, book straps, jacket or other clothes are not caught in the handrails or bus door.
- Walk away from the bus. After you get off the bus walk at least five giant steps (about ten feet) away from the side of the bus and the street before turning to walk into school or toward home. Never walk behind the bus.
- Tell the bus driver. If you drop something near the bus or have any other problems, tell the bus driver. Never bend down near or under the bus where the bus driver may not be able to see you. 🕥
