CAPITAL PROJECTS SALES TAX

When Aiken County voters go to the polls this November they will have an opportunity to extend the Aiken County Capital Projects Sales Tax for another seven years. Passed for the first time in November 2000, the onecent tax has funded an extensive list of improvement projects in North Augusta, the City of Aiken and Aiken County. North Augusta projects funded with the sales tax have included improvements at Summerfield Park, Walnut Lane Park and Riverview Park. Seventeen miles of city streets were repaved and one and a half miles of the Greeneway along the riverfront will be completed this summer. Additionally, the successful streetscaping on Georgia Avenue will be extended to Buena Vista, Pine Grove, Spring Grove,

Jackson and West Avenues later this year.

Originally anticipated to extend the full five years, the Capital Projects Sales Tax will generate all of the revenues anticipated in less than five years. Accordingly, the Aiken County Council and the city councils of each municipality will offer voters the opportunity at the November general election to extend the tax and continue to implement public improvement projects. North Augusta projects proposed to be funded with the second round of Capital Projects Tax proceeds total \$19,350,000. The projects approved by the City Council for funding under round two of the one-cent Capital Projects Sales Tax are:

PLANS FOR THE MUNICIPAL COMPLEX, TOWN CENTER, AND RIVERFRONT ROAD EXTENSIONS

At its annual planning retreat, North Augusta Forward, held in May, the City Council and Planning Commission spent two days discussing a variety of issues related to the growth and development of North Augusta. The proposed new municipal complex and its role in the future development of the town center area of the downtown were topics of considerable interest and discussion.

The town center area is roughly centered on the 100 block of Bluff Avenue and is generally described as the area that extends from the Greeneway on the south to Clifton Avenue on the north and from Georgia Avenue on the east to West Avenue on the west. Not all of the properties within that area are included in the redevelopment planning for the town center but many will be affected by the plans to create new street connections to the riverfront through the town center.


The riverfront road extensions project is currently under design by the South Carolina Department of Transportation (SCDOT). An extension of Georgia Avenue, preliminarily referred to as "Center Street", will be constructed to connect Bluff Avenue with the new Hammond's Ferry development. Secondary access roads into Hammond's Ferry include the extensions of West Avenue and Crystal Lake Drive. Construction is expected to commence in 2005. Crystal Lake Drive and the Georgia Avenue extension will be constructed first. West Avenue will be done later and will depend on the availability of construction funding.

The triangular parcel of land created by the new "Center Street," Georgia Avenue and the Greeneway has been identified as a potential site for the new municipal complex. (Businesses that were formerly located on the triangular parcel include the Downtown Motel, Savannah River Art Glass and Wine World.)

A majority of the City Council believes that the triangular parcel may be an excellent location for the new city facility because of its visibility and accessibility. The council has requested the city's architects, The Boudreaux Group of Columbia, to continue the design process and to develop a "test fit" of a new building on the downtown site. The results of the work of The Boudreaux Group will be reviewed by the City Council later in the year.

PALMETTO PARKWAY

More than one hundred people, including state and local elected officials from both South Carolina and Georgia, attended the ceremony to officially open the new interstate link between South Carolina and Georgia.

Interstate 520, known as the Bobby Jones Expressway on the Georgia side of the Savannah River, was completed to Laney-Walker Boulevard in August 1998. The newest section required two years to build and continues the road another three miles aross the Savannah River to US 1/Aiken-Augusta Highway in North Augusta. The final phase of the project will carry the Palmetto Parkway another six miles from the US 1 interchange to I-20 near Exit 5, the US 25 interchange. When the project is completed the large truck traffic through North Augusta on Martintown Road, Knox Avenue and Edgefield Road will be dramatically reduced.
