# Construction Begins on New — MUNICIPAL CENTER —

Construction of the city's new municipal center is scheduled to begin in January. The 68,000 square foot, brick facility includes four levels. The main level or first floor will be occupied by the departments of Finance and Building Standards (currently located in the former South Carolina Highway Department building). The first floor also includes exhibit and meeting space for the North Augusta Cultural Arts Council and the Heritage Council of North Augusta. The second floor will be occupied by the departments of Economic and Community Development, Engineering and Stormwater Management. Information Technology and Administration staff will occupy the third floor along with Council Chambers. The first, second and third floors include meeting space, space for records storage and office space for additional staff as it becomes necessary. The fourth floor consists of a public meeting/event room with a kitchen and several covered terraces.

Since its incorporation in 1906, North Augusta's administrative offices have been housed in three different locations. The first was the old "Fire Barn" in the 500 block of Georgia Avenue. As the city grew so did the need for workspace and records storage and in 1955 the city offices were relocated to 400 East Buena Vista Avenue. In 1984, again to accommodate the need for additional space, a new municipal building was constructed next to the existing building. The Department of Public Safety remained in the existing facility and the city's administrative offices moved to the new facility, where they remain to this day.

Since 1984, the city has met the increasing need for space through a number of renovations to both the public safety and municipal buildings. In 1994, one of the municipal building's two stairwells was converted to storage space to meet state records retention requirements. In 1996, the first floor hallway was converted to office space. In 1998 and again in 2002, the public safety building was remodeled to accommodate increased space needs for municipal court operations and the criminal investigations division. Also in 2002, to free up needed space, the staff of the Building Standards Department was relocated from the second floor of the municipal building to the old "drivers license" building across the street. The municipal building space was then reorganized to provide for a stormwater manager, code compliance officer and a planning position in the Department of Economic and Community Development. Designed to house a maximum of seventeen people, the 10,000 square foot municipal building now provides office space for twenty-two employees.

#### CITY ADMINISTRATOR RETIRES

North Augusta's City Administrator, Charles B. Martin, recently announced his retirement after almost 27 years of service.

In a 1980 Aiken Standard article after his selection as the city's second administrator, Martin stated, "The city should make itself attractive to developers, but at the same time preserve the residential integrity the city has enjoyed in the past." Serving under four mayors and numerous council members during his tenure as North Augusta's city administrator, Martin has accomplished that, quietly shaping North Augusta from a sleepy "bedroom" suburb of Augusta, Georgia, into a vibrant and desirable community in which to live, work and do business.

Since Martin took the reins as administrator in 1980, the city's population has increased by over 40 percent and the city limits have increased from slightly over eight square miles to almost 20 square miles. The number of full-time city employees has grown from 125 to almost 200 and the city budget has increased from approximately \$3.5 million to almost \$30 million.

During his tenure, North Augusta has changed dramatically, enhancing the quality of life of residents and attracting quality growth and development. Accomplishments, to name a few, include numerous advances in technology, construction of the Community Center, the Municipal Building and the Riverview Park Activities Center, major enhancements to Riverview and other city parks, development of new park amenities such as the Greeneway Trail and Walnut Lane Neighborhood Park, and the realization of development of the riverfront. As well, major water and sewer line extensions and water plant expansions have been completed.

In the letter to the City Council announcing his retirement, Martin credited city leaders and employees, writing, "The growth and success of the City of North Augusta during this time is directly related to your leadership and to the efforts of the many fine staff members and dedicated employees of our organization."

According to Mayor Lark Jones, "Much of the success the City of North Augusta has had over the last 25 years has been due to the consistent and effective leadership of Charles Martin. Rarely does a city keep a manager or administrator for that length of time. His adherence to orderly planning, scheduling and sound fiscal policies have made the job of elected officials easier. Most citizens appreciate the things that are going on in North Augusta. Charles Martin has played a large role in much of it."

Mr. Martin plans to enjoy his retirement by traveling and spending time with wife Ann, sons Bo and Russ (Shelly), and grandchildren, Katie, 10, Chandler, 8, and Skylar, 4. After that, says Martin, "Then we will see what opportunities may be available that would allow us to be constructive." His last day as city administrator will be February 28, 2007.

#### NEW MUNICIPAL CENTER continued

In 2002, to address the growing need for office space, the City Council authorized the first phase of a multi-year effort to design and construct a new municipal center and funds were included in the 2003 budget to begin the process. A primary goal of the City Council was designing a facility that could grow with the city through the coming century.

After soliciting proposals for the new center, the City Council selected the Boudreaux Group of Columbia, South Carolina, to manage the design and supervise the construction of the new municipal center. In early 2004, the Boudreaux Group held a public meeting to solicit citizen input on possible additional uses, potential funding for those uses, the general area where the building should be located, and the kind of image the new facility should present. The Boudreaux Group then conducted a space needs analysis, performed site evaluations and developed preliminary designs for the City Council to consider.

In 2005, the City Council purchased 1.8 acres of land from North Augusta 2000 to locate the new municipal center. The site was selected based on the recommendation of the Boudreaux Group because of its visibility and accessibility. The property is located south of Bluff Avenue between Georgia Avenue and a planned extension of Georgia Avenue and is adjacent to a 0.6 acre parcel purchased by the city a number of years ago. The Georgia Avenue extension, named Center Street, will connect Bluff Avenue with the new municipal center and eventually, the Hammond's Ferry development. Access to the new municipal center will be available via Georgia Avenue and Center Street.

Construction on the new municipal center is expected to be complete by the summer of 2008. Once the new facility is complete, the former municipal building will be occupied by the Department of Public Safety and Municipal Court.

#### 2007 CITY BUDGET ADOPTED -

The 2007 Consolidated Municipal Budget totaling \$29,795,496 was approved by the City Council on November 20, 2006. The city's mill levy for 2007 (2006 tax year) is 81.08, unchanged from 2006. In 2007, revenue from 72.13 mills will be collected for General Fund purposes and revenue from 8.95 mills will be applied to the Capital Projects Fund.

## WINTER BASE PERIOD IN EFFECT

The City of North Augusta uses a "Winter Base Sewer Rate System" for calculating sewer service charges. Three months of actual water usage are used to calculate sewer charges for the remaining nine months of the year. The three month base period covers the three water meter readings taken between December 10 and March 9. Water meter readings are based on the actual water consumed for the month preceding the reading.

Each utility customer is billed a sewer service charge based on actual water consumption during the three winter base months. The average consumption of these three months is then used for the remaining nine billing periods of the year. New customers with no winter base history are charged an amount equal to the average of all residential sewer customers. For more information about the Winter Base Period, please call 803-441-4212.

Calendar year 2007 Business License renewal applications will be distributed to current licensees during the last week of December. Completed applications are due on February 1, 2007. A delinquent payment penalty of ten percent will be added to applications received after February 1. The penalty will increase by an additional five percent each month until received.

Business licensees should carefully examine the information on the application to confirm that it is correct. Corrections or additions should be written directly on the application form. Once properly completed and signed, the application should be returned to the city with the correct fee. The turn around time on a properly completed business license application is usually within ten days.

#### PALMETTO PARKWAY PROCEEDS

Construction on the final phase of I-520, the Palmetto Parkway will begin in January and is scheduled to be opened to traffic in 2009. United Contractors, the team that completed Phase 1 in 2004, was awarded the \$130 million contract for Phase 2.

# TAX NOTICES COMING SOON

Tax notices on real and personal property and on merchants' inventory for the 2006 tax year will be mailed to property owners in January. Tax payments are due by May 1, 2007. For those property owners whose taxes are escrowed by a mortgage company, tax notices will be mailed directly to the mortgage company.

# CENTER STREET CONSTRUCTION

Construction will begin soon on the planned extension of Georgia Avenue. The new \$5 million roadway, to be called Center Street, will extend from the current intersection of Georgia Avenue at Bluff Avenue to the Savannah River through the Hammond's Ferry development. Funded with state and federal appropriations, the new street will provide access to the new municipal center and other buildings to be constructed in the town center area.

Bids will be accepted by the South Carolina Department of Transportation in January and construction of Center Street will commence in March or April. Road construction will be coordinated with the grading work on the adjacent municipal center site.

## Public Safety PROGRAMS IMPLEMENTED

#### **Meth Watch**

In response to the discovery of illegal methamphetamine (meth) drug labs operating in the North Augusta area, the city's Department of Public Safety, in cooperation with the South Carolina Office of the Attorney General and the North Augusta Chamber of Commerce, has implemented the South Carolina



Meth Watch Program. The program is designed to help curtail the theft and improper sale of pseudoephedrine and other common household products used in the illicit manufacture of methamphetamine.

Participating retailers place products commonly used in the manufacture of meth where they can be easily monitored and post Meth Watch signs and tags in prominent locations in the store. Purchase limits are also imposed to prevent high volume sales of pseudoephedrine and other methamphetamine components.

North Augusta businesses currently participating in the MethWatch Program are CVS Pharmacy, Dollar General, Eckerd Pharmacy, Kroger, Parks Pharmacy, Publix Supermarket, Thomas & Howard and Wall Hardware.

### **Project Lifesaver**

As of November 1 local families and caregivers of individuals suffering from Alzheimer's Disease, Autism, Down Syndrome, Dementia and other conditions that cause disorientation and can result in wandering or getting lost have a new option to help keep loved ones safe.



The North Augusta Department of Public Safety, Aiken County Sheriff's Office and City of Aiken Department of Public Safety have joined forces with Project Lifesaver International, a non-profit public safety program used to assist in locating missing persons.

Project Lifesaver clients wear a small wrist or ankle band that emits a continuous radio tracking signal. When a caregiver notifies law enforcement that a Project Lifesaver participant is missing, a special mobile tracking unit is activated to quickly locate the missing person.

The program has been adopted by over 325 police departments in 37 states. To date, over 1,300 wanderers have been located. The average recovery time, formerly often hours or days, has been reduced to less than 30 minutes. Project Lifesaver eliminates the need for costly searches involving teams of officers, scent-tracking dogs, volunteers and expensive search equipment including helicopters and heat locating devices.

Initial funding for the local program was made possible through a \$15,000 grant from the Sertoma Club of North Augusta. Continued funding for the program is being sought through donations and grants.
