Center Street and Municipal Center — COMMENCE CONSTRUCTION —

After years of planning, two significant downtown projects have commenced construction. Center Street, the planned extension of Georgia Avenue that will connect the downtown area with the riverfront, was officially started on May 29. A project of the South Carolina Department of Transportation, Center Street will extend from the intersection of Georgia Avenue and Bluff Avenue through the Hammond's Ferry development to Railroad Avenue, and ultimately to the Savannah River. Center Street will cross over the Greeneway Trail and the Greeneway will pass through a tunnel below the new road. Direct access from the Greeneway onto Center Street will be provided.



An official groundbreaking for the new municipal center was held Monday, June 18. Taking part were Mayor Lark Jones, members of City Council, Department Directors and representatives from The Boudreaux Group, architects, and M.B. Kahn Construction Co., Inc.

Bluff Avenue will be closed to through traffic between West Avenue and Georgia Avenue for most of the period of construction. Center Street construction is scheduled to be completed in June 2008.

Center Street and Bluff Avenue will provide the primary access to the new municipal center and other buildings to be constructed in the town center area. Construction on the city's new 60,000 square foot municipal center will begin in June. Because of the proximity of the two projects, the initial phases of construction on both projects will be closely coordinated. The municipal center is scheduled to be completed in late 2008.

Greeneway Trail Section Closing

As a result of the Center Street construction, a section of the North Augusta Greeneway, from the Greeneway tunnel at Riverside Boulevard (Georgia Avenue/13th Street Bridge) to the new Greeneway access near the intersection of West Terrace and Alta Vista Avenue, has been closed and will remain closed through May of 2008. If construction is completed earlier than anticipated the Greeneway may be reopened earlier.

North Augusta KEEPING IT CLEAN & GREEN

North Augusta recently teamed with Aiken County and PalmettoPride, the state's anti-litter organization, for Litter Awareness Week. In addition to cleaning up unsightly litter, the purpose of the weeklong event, held April 14 through 21, was to educate people on the effects of litter on our environment and in our communities. Activities during the week included numerous litter collections, public service announcements and educational opportunities for children and adults.

North Augusta's sixth annual Kids Earth Day event offered a unique opportunity to educate area youth and adults on the effects of litter and pollution and other important environmental issues. Dozens of area agencies and organizations participated and provided numerous fun and educational hands-on activities and demonstrations to thousands of event goers.

For the event, the city's stormwater management department brought out its stormwater model which demonstrates how rainwater travels, collecting fertilizers, dirt and other debris as it travels through the storm drains and eventually into streams, ponds and other bodies of water. The city's recycling department brought a large bale of crushed aluminum cans and challenged kids to guess the weight for a chance to win a bike.

Information about North Augusta's Blue Bag Recycling Program was also available as well as a display of items that can, and should, be recycled.



North Augusta's litter reduction crew, employees in the Property Maintenance Division of the Department of Parks, Recreation and Leisure Services displayed a large volume of litter collected in a one day period from three North Augusta roads (Highway 1-78 from Revco Road to the Georgia state line, Atomic Road from Martintown Road to the Highway 1-78 Overpass and Highway 25 from Bradleyville Road to Walnut Lane).



The collected litter was displayed next to the stage where Kids Earth Day guests were treated to two exceptional performances of the *Litter Trashes Everyone* puppet show. The show, sponsored by PalmettoPride and performed by the Columbia Marionette Theatre, uses humor and music to relay the message that everyone can do their part to help prevent and control litter.

Litter can affect the visible beauty of our community and highways. Some of the negative effects of litter are:

- Potential new businesses and industries locate elsewhere.
- Tourism decreases.
- Community pride diminishes.
- Litter encourages criminal activity.
- Litter encourages graffiti.

Every resident can help reduce litter:

- When walking, pick up litter and properly dispose of it.
- Use a litter bag in your vehicle.
- Reduce, reuse and recycle.
- Use returnable, reusable or refillable drink containers.
- Put your garbage out for collection as close to pickup time as possible.
- Organize a community cleanup.
- Set a good example. Don't be a litterbug.

STREETSCAPE PHASE 2 UNDERWAY

A segment of phase 2 of the Downtown Area Streetscape program is currently under construction. The work consists of improvements to West Buena Vista Avenue between Georgia Avenue and West Avenue. The contract, awarded to Beam's Construction, includes new sidewalks, curbing, decorative streetlights, mast-arm traffic signals at West Avenue, new pavement, and storm drainage system improvements. One significant change resulting from the new construction will be the addition of on-street angle parking on Buena Vista Avenue adjacent to Jackson Square.

Although the contract requires that one lane of traffic be kept open at all times, motorists are encouraged to avoid this block and to use alternate routes and alleys as much as possible. The project should be substantially complete by the end of July.

Additional portions of the Downtown Area Streetscape program will start this summer as soon as the overhead utility lines on West Avenue have been removed by South Carolina Electric and Gas Company. For more information, call 803-441-4220.

Drinking Water — TEST KITS —

In recent months, many North Augusta residents have received kits containing a small plastic bottle and a leaflet offering a free drinking water test. The leaflet states that "for the next two weeks we will be conducting relative tests on the water for the residents in this district." The City of North Augusta is not conducting or endorsing these tests.

The city would like to advise residents receiving these kits that:

- The tests are not being conducted by any state or local agency.
- The city regularly tests its drinking water to ensure that it meets all federal and state guidelines. On this basis no additional testing is needed.
- The city never requests its customers to provide water samples for testing.
- The test offered is conducted by a private company that sells water processors and drinking water systems. It is a sales promotion.
- Participation in the test may result in a presentation of products distributed by the company conducting the test.

Consumers should know that it is not possible to carry out any meaningful analysis on such a small sample of water. Several different samples of water totaling more than a liter are required for expert sampling and analysis.

If you do suspect a problem with your drinking water, contact the city's superintendent of Water Production at 803-441-4325 or your local water company. These people are qualified to take and test samples.

No tap water is 100 percent pure, and many people have limited knowledge about safe water. Also, consumers may have little information about the functions and limitations of home water treatment systems. As a consequence, some people buy expensive water treatment equipment they don't need, to cure problems that don't exist.


The results of an in-home test will generally show the presence of some minerals in the city's water. All water, except distilled water, contains some minerals. In general, the presence of minerals is not a health threat and many minerals are beneficial.

2006 Drinking Water Quality Report

The Savannah River is the source of North Augusta's drinking water. River water is pumped to the treatment plant where conventional treatment processes are used to produce high quality drinking water. As required by federal and state laws, the City of North Augusta routinely monitors for more than 80 contaminant's. Based on the results of the required tests, **North Augusta's drinking water is safe and meets all federal and state requirements.** The city's 2006 Drinking Water Quality Report, also required by federal law to inform the public about the quality of drinking water, was included in the city's April utility statements. FOUNDER'S STATUE UNVEILED

A life-size bronze statue of North Augusta founder James Urquhart Jackson was recently unveiled in John C. Calhoun Park. A project of the Heritage Council of North Augusta, the statue will eventually be placed in a park dedicated to Jackson and his accomplishments.



The statue is the first of several phases of the Heritage Council's North Augusta Heritage Tourism Project: Tracing the Footsteps of James U. Jackson. Future phases of the project will include the development and installation of interpretive signage at designated historic buildings and community historic sites. Many of the buildings and sites are listed on or are eligible for listing on the National Register of Historic Places and exist as a direct result of Jackson's achievements.

According to Mayor Lark W. Jones, "The statue is long overdue. Previously, we had no public statues in North Augusta. James U. Jackson is an obvious choice for our first. The likeness is wonderful and the pose shows his visionary character. Thanks to the Heritage Council and the donors who made it happen."

The unveiling of the Jackson statue served as the official kickoff of North Augusta's first annual Yellow Jasmine Festival. Festival highlights included an exhibit and sale of entries in the Yellow Jasmine Art Competition, a garden expo with vendors, displays and professional speakers, vendors of fine art and handmade crafts, free children's activities, and an evening street party followed by a beautiful fireworks finale over historic Rosemary and Lookaway Halls.

The Yellow Jasmine Art Competition was judged by Augusta artist David Mascaro. Mr. Mascaro awarded first place to Elizabeth Moretz-Britt (coincidently, this year's poster artist), second place to Georgene Wright, and third place to Doris Sofge. Honorable mentions were awarded to Jo Ann Taylor and Helen Hutson.

Planning Commission Approves —— DEVELOPMENT CODE ——

The final draft of the updated Development Code for the City of North Augusta was approved by the North Augusta Planning Commission at its April 19 meeting and has been forwarded to the City Council for approval. The Development Code is a comprehensive update of the city's zoning and development regulations. It will provide the rules and regulations for the use and development of land and buildings including subdivisions and new commercial projects in the city.

The Planning Commission worked for several years on updates to the regulations. The work on the Development Code was done in conjunction with the preparation of the city's 2005 Comprehensive Plan. State law requires that the regulations in the Development Code be consistent with the policies outlined in the Comprehensive Plan.

The City Council began its discussions of the proposed changes to the regulations at the 2007 North Augusta Forward planning retreat on May 10 and 11. The council will meet in a series of workshops during July and August to complete its review and discussion of the document. It is anticipated that the new North Augusta Development Code will be adopted in September.
