We also have three newer underground detention facilities at our new public safety facilities listed for pricing as well. Not all units will require cleaning, but we would like a bid for each unit shown one on the bid sheet.

We are considering a contract for the services for a 2-year period. Whether we can enter into a contract will depend on the total costs for the services. If the bids exceed the allowance for these services, a contract may not be awarded for this work.
