## Sanitation Department Encourages Use of Plastic Bags and Cans By Customers

This is the time of year that many persons are doing a great deal of yard work which generates larger volumes of trash and garbage for collection. The City would like to encourage all of our sanitation customers to use plastic cans and plastic bags for garbage and trash collection. Why plastic cans? Plastic cans are lighter, very durable, last longer than metal cans since they do not rust, and are easier to handle by sanitation workers.

We recommend that lighter items such as leaves and small limbs be placed in plastic bags. This will allow your garbage cans to be used for larger limbs and household garbage. Boards, etc. should be stacked as neatly as possible behind the curb line or off the paved surface. No grass clippings, leaves, or small yard trash should be in the street. This will prevent trash from washing down the street and clogging the storm drain lines. Also, due to the mechanical pick-up of large amounts of yard trash, please do not place trash under low wires, trees, or close to mailboxes or parked cars.

The City's sanitation department thanks you for helping them to meet your sanitation needs.

# 9-1-1 System Now In Service In Aiken County


On May 2, 1988, at 9:11 a.m., the emergency service number, 9-1-1, was placed into operation for residents of Aiken County. By dialing 9-1-1 your call will go directly to the police agency serving you. This agency will be responsible for dispatching the appropriate fire, police, and medical services.

Placing the 9-1-1 system into operation in Aiken County began on January 21, 1986, when, in a joint effort with the cities of North Augusta and Aiken, Aiken County entered into a contract with Southern Bell to provide the emergency service number, 9-1-1, to the citizens of Aiken County.

Since that time, thousands of manhours have been spent on the

installation of equipment, renaming of county roads, setting up computer banks, and training people on the operation of the equipment. This training by Southern Bell officials was for all persons involved in receiving emergency calls. Testing of the equipment began in early February and was done by calling a test number from locations across the county to check the information given.

The 9-1-1 number should be reserved for emergency calls only. Any other calls


## Audit of City's Financial Statements for FY 1987 Completed

The City's independent auditor, Baird and Company, has completed the audit of the City's financial statements for the year ending December 31, 1987. Their report shows that for the seventh consecutive year, the City has received an unqualified audit opinion, meaning that the basic financial statements of the City are fairly represented in conformity with Generally Accepted Accounting Principles.

The pie charts to the right depict the sources of revenue, the functional areas of expenditures, and the percentage of the total budget for the General Fund for 1987.

The following list shows the sources and amounts of revenues and expenditures and the percentage of increase or decrease from the previous year.




#### UTILITY FUND

# Construction of New Public Safety Station Underway

Construction is now undrway on the North Augusta Public Safety Station II, located at the intersection of Five Notch Road and Interstate 20. This 9,700 square foot building, designed by the architectural firm of Virgo Gambill Rhoades, is being constructed by R.W. Allen Construction Company of Augusta.

The new public safety station will include an apparatus room large enough for four trucks, an indoor firing range, a training/meeting room, and three bedrooms. Officers will be on duty 24 hours a day at this new facility.

The Five Notch Road station will allow the Public Safety Department to greatly increase its response time to all fires in the northern portion of the City's fire coverage area. The site is large enough for future training facilities.

The contract price for this facility is \$750,000. Construction is expected to be completed by the end of 1988.


