The Redevelopment Plan and the TIF District were adopted by Ordinance No. 96-10 on December 16, 1996. The proposed amendments were given preliminary approval by Resolution 2013-01 of the City Council adopted on January 22, 2013, a copy of which is available for review at the offices of the City Clerk at the Municipal Building, 100 Georgia Avenue, North Augusta, South Carolina, during normal business hours.

#### ITEM 10. FINANCE: Taxes, Fiscal Year 2014 – Ordinance, First Reading

An ordinance has been prepared for Council's consideration on first reading establishing the tax rate on all taxable property within the City of North Augusta for the Fiscal Year 2014.

The period for which the tax levy is due on all taxable property, except for motorized vehicles, shall be from January 1, 2013, to December 31, 2013. The period for which the tax levy is due for all motorized vehicles which are required to be licensed by Section 53-3-110, Codes of Laws of South Carolina, shall be from January 1, 2014, to December 31, 2014.

The tax levy imposed upon all taxable property shall be 74.21 mills. Revenues from 71.85 mills shall go to the General Fund. Revenues from 2.36 mills shall go to the Capital Projects Fund.
