Ms. Karen Ramos, Manager of Drinking Water Enforcement for the South Carolina Department of Health and Environmental Control, is requesting the City of North Augusta consider providing new drinking water service to serve 10-mobile homes owned by Ms. Mary Bodie located at 454 Carolina Springs Road. Ms. Ramos indicated the mobile home park's private drinking water well is currently contaminated with high levels of nitrates.

Furthermore, Ms. Ramos indicated Bodie Mobile Home Park will not be able to comply with the City's Development and Zoning Standards for Manufactured Housing and Mobile Home Districts as outlined in Article 3 of the City's Development Code.
