## **REGULAR COUNCIL MEETING**

**ITEM 5. FINANCE: Proposed Annual Consolidated Budget for Fiscal Year 2014 – Ordinance, Third and Final Reading**

An ordinance to adopt the proposed Fiscal Year 2014 Consolidated Budget is submitted for Council's consideration on third and final reading.

**ITEM 6. FINANCE: Taxes, Fiscal Year 2014 – Ordinance, Third and Final Reading**

An ordinance has been prepared for Council's consideration on third and final reading establishing the tax rate on all taxable property within the City of North Augusta for the Fiscal Year 2014.

The period for which the tax levy is due on all taxable property, except for motorized vehicles, shall be from January 1, 2013, to December 31, 2013. The period for which the tax levy is due for all motorized vehicles which are required to be licensed by Section 53-3-110, Codes of Laws of South Carolina, shall be from January 1, 2014, to December 31, 2014.

The tax levy imposed upon all taxable property shall be 74.21 mills. Revenues from 71.85 mills shall go to the General Fund. Revenues from 2.36 mills shall go to the Capital Projects Fund.
