ITEM 9. <u>PERSONNEL:</u> Employee of the Quarter, April, May, and June, 2015 – Benjamin J. (BJ) Clark, PSO

The City of North Augusta Employee Recognition Committee would like to recognize the employee of the quarter for April, May, June 2015, Benjamin J. (BJ) Clark, PSO for the Department of Public Safety.

BJ began his employment with the City of North Augusta on August 31, 2011.

Public Safety officer Clark serves as one of Public Safety's instructors for defensive tactics, OC, baton, and Tasers. He is committed to informative, realistic, and hands on training. PSO Clark shows great enthusiasm while instructing which promotes for a better learning environment. His willingness to extend the extra effort in training officers does not go unnoticed by his superiors.

PSO Clark demonstrated his exemplary service on Tuesday, April 14 on a routine call. PSO Clark responded to the area of Georgia Avenue and Buena Vista in reference to an unclothed woman assaulting another woman in the middle of the roadway. When PSO Clark arrived, he quickly took control of the situation and determined that the unclothed woman was suffering from severe mental illness. He quickly found a blanket to cover the woman and escorted her to his patrol vehicle and called for EMS to respond to the location. The woman was aggressive towards PSO Clark, other officers, and the public. PSO Clark remained calm and assured the woman that she was ok. EMS arrived on scene and PSO Clark assisted EMS in keeping the woman calm so they could load her into the ambulance for transport.

Public Safety officers are trained to handle all kinds of calls but the manner in which PSO Clark took care of this call minimized the embarrassment for the woman's family and protected the woman's dignity. Most importantly, PSO Clark made sure the woman received the proper medical treatment she needed. PSO Clark demonstrated outstanding effort and exemplary attention to duty while handling this call.
