ITEM 8. <u>FINANCE:</u> Committee for Selection of Auditors, Appointment by Mayor

Section 5-7-240 of the South Carolina Code of Laws requires independent annual audits of Cities' financial records. The City may, without requiring competitive bids, designate an auditing firm for each year or for a period not to exceed 4 years. It has been customary for the North Augusta City Council to select a qualified accounting firm for contract periods of 4 years.

Mayor Jones wishes to appoint an Auditor Selection Review Committee which will consist of three members of City Council; Councilmembers Jimmy Adams, Bob Brooks, and Ken McDowell; the City Administrator, B. Todd Glover; and Finance Director, Cammie T. Hayes. This committee will review the qualifications of firms responding to the City's Request for Qualifications (RFQ) and make a recommendation to the full Council.
