### RESOLUTION NO. 2016-29

# AUTHORIZING THE PROPERTY MAINTENANCE DIVISION TO REPLACE TREES UTILIZING FUNDS FROM THE TRANSPORTATION IMPROVEMENT FUND AND THE CAPITAL PROJECTS FUND

WHEREAS, the Property Maintenance Division has discovered 74 trees that are in need of replacement and past their maintenance guarantee period (45 in Wando Woodlands, 10 in Bergen Place West, 7 in the Village at Bergen Place, and 12 on Georgia Avenue); and

WHEREAS, the total estimated cost is not to exceed \$36,600 which includes a tree root barrier to aid in the prevention of sidewalk and curb heaving; and

WHEREAS, the 2016 budget does include funds for tree replacement, but those funds have been dedicated to tree replacement in other areas of the City; and

WHEREAS, Wando Partners has paid \$60,500 to the Transportation Improvement Fund for Martintown Road access improvements that cannot be done at this time, and these payments would not cover the cost of the road access project; and

WHEREAS, there is also funding available in the Capital Projects Fund that can be used towards tree replacement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH AUGUSTA, IN MEETING DULY ASSEMBLED AND BY THE AUTHORITY THEREOF, THAT:

The Property Maintenance Division is hereby authorized to replace 74 trees with funding not to exceed \$25,000 from the Transportation Improvement Fund and not to exceed \$13,000 from the Capital Projects Fund.
